Our policies are classified under 4 sections:

- 'A Policies' which are policies that have their basis in legislation and therefore impose a legally binding duty on the school and its staff.
- **'B Policies'** which are written in consultation with staff, children, parents and governors.
- 'C Policies' that in general concern teaching, learning and staff development
- **'D Policies'** that are issued by Wiltshire LA Human Resources Department and address many of the issues around conditions of employment, professional development, absence from work etc, which will be of relevance to all employees.
